#### **TERMS OF THE AIRLINES :**

The travel site www.sumeruholidays.com, mobile site and Smartphone App Platforms like iOS and Android are maintained by Sumeru Travel Solutions LLP It is an IATA certified travel company existing compliant with the laws of the Republic of India. By accessing or using this site or using any of its services, you are agreed on terms and conditions mentioned below, including any supplementary guidelines and future modifications.

Sumeru Travel Solutions LLP merely acts as a facilitator to enable the User to book a flight ticket. The contract of service for utilization of the flight is always between the User and the concerned airline.

As a facilitator Sumeru Travel Solutions LLP has no control or authority over the logistics of the airlines and therefore is not liable for any loss, direct or incidental, that a User may incur due to such change or cancellation of a flight.

Different tickets on the same airline may carry different restrictions or include different services and price.

The baggage allowance on given fare is as per the terms decided by the airline, and Sumeru Travel Solutions LLP has no role to play in the same.

Some airlines enter into "code share" agreements with other Airlines. This means that on certain routes, the airline carrier selling or marketing the flight ticker does not fly its own aircraft to that destination. Instead, it contracts or partners with another airline to fly to that destination. The partner airline is listed as "operated by" in the booking flow.

If your flight is a code share, it will be disclosed to you in the booking process and prior to payment.

Sumeru Travel Solutions LLP will disclose any such code-share arrangements to the User, only when the ticketing airline discloses it to Sumeru Travel Solutions LLP in the first place.

#### Prices on the Website:

The price, which we offer on Sumeruholidays.com, generally, includes base fare, applicable government taxes, service fee, convenience Fee; payment gateway charges. It never comprises any personal expense or other additional charges. User agrees to pay all statutory taxes, surcharges and fees, as applicable on the date of travel.

#### Mode of Payments & the Policies:

Our payment gateway is completely secure and customers can make the online payments through a safe transaction process which will ensure that their personal security data will not be revealed in any circumstances.

## **Flight Amendment & Cancellation Policy**

- Every booking made on Sumeru Travel Solutions LLP is subject to cancellation charges taken by the airline, which may vary with respect to flight and booking class.
- Sumeru Travel Solutions LLP levies negligible amount of Rs. 300 per passenger/per sector for domestic air tickets as cancellation/reschedule service charges.
- Sumeru travel Solutions LLP levies applicable charges for the cancellation
  of International air tickets as per the airline policies. However, the
  convenience fee paid to Sumeru Travel Solutions LLP paid at the time of
  booking of an international ticket is a non-refundable fee. Please also
  note that additional service charges will also be levied for cancellation
  on international tickets. Customer must check with Sumeru Travel
  Solutions LLP on the total cancellation charges before booking or
  cancelling the ticket.
- Some bookings may be non-refundable as per the specific airline's policy.
- Some bookings cannot be cancelled partially as per the specific airline's policy.
- In case of direct cancellation through airlines, refunds will be given according to airlines charges along with our service charge as above mentioned. After flight departure & in case of No Show, we don't entertain any cancellation request.
- In case of No-show the refund amount is entirely depends upon the airlines. Sumeru Travel Solutions LLP has nothing to do with the refund amount. Sumeru Travel Solutions LLP will refund the same amount to the customer, which we receive from airlines in case of No-Show.

# **Cancellation Charges:**

If you have booked group tour where Sumeru Travel Solutions LLP requires to book services like hotel, air, transportation etc. in advance because all group need to travel at the same time and stay together in one hotel. Our motto is to avoid all inconvenience to guest & enjoy their tour happily. And for blocking the reservations, we need to make the payment in advance. In such situation if tourist does not availed the services then we have to bare the cancellation charges. In order to cover our expected losses from the cancellation there's a set scale of charges which must be paid by the guest if you or anyone traveling with you cancels the tour or cancel any services or arrangements that form part of your booking with us. The cancellation charges are a percentage of total tour cost which varies with the number of days prior to departure date.

## **General Cancellation policies**

- For cancellations done prior to the 30 days or more of the date of departure, initial deposit amount or 35% of the tour cost (if full paid) will be charged as cancellation charges.
- For cancellations done between 29 days to 15 days prior to the date of departure, 90% of the tour cost will be charged as cancellation charges.
- For cancellations done between 14 days to 01 days of the tour, 100% of the tour cost will be charged as cancellation charges
